Supporting documents include: a copy of your itinerary, accommodation information, name(s), and contact details of who you will be travelling with, any travel tickets (such as flight, train, or bus tickets), and a letter of support from your parent / legal guardian, Passport or Driving License/Photo ID of your guardian.
- 3. This application must be signed by your parent / legal guardian.
- 4. If approval is granted, you will receive an email notification from your Under 18 Coordinator.
- 5. If you are travelling to and from the airport at risky hours, you must book UWA transport services at your own cost. Risky hours include any time between 10.00pm and 6.00am.
